

TRELLEBORG VIKING, INC. LIMITED WARRANTY

Trelleborg Viking, Inc ("Viking") warrants, to the original owner for a period of one year, every new Viking Dry Suit against leakage. Should the suit leak within one year from the date of purchase by the original owner, upon receipt of the suit, postage prepaid and with satisfactory proof of purchase, Viking will **repair** or **replace** the suit at no charge. This warranty does not cover the latex parts, such as hoods, neck seals or cuffs.

This warranty also does not cover suits which are used for diving in a chemical environment. Each diving operation must be evaluated by the on-site supervisor and the diver himself. If there is any doubt regarding the hazard level the diver must not dive. Every hazard varies with time of exposure and concentration.

Viking dry suit zippers are warranted for 90 (ninety) days from date of purchase.

This warranty becomes null and void if:

- 1) The user has not been properly instructed in the use and care of the suit by a certified diving instructor.
- 2) The product is not registered with Trelleborg Viking, Inc within 10 (ten) days of purchase.
- 3) The product has not been properly serviced and maintained according to the Viking owners manual.
- 4) Unauthorized modifications have been made to the product.
- 5) The product has been abused or subjected to conditions which are unusual or exceed the products intended service.

Be sure to complete the attached warranty card and return it to Trelleborg Viking, Inc. immediately. No warranty claims will be

honored unless a completed warranty card is on file at Trelleborg Viking.

NO OTHER WARRANTY, EXPRESS OR IMPLIED, ORAL OR WRITTEN IS MADE BY OR SHALL BIND VIKING OR ANY OF ITS AFFILIATES WITH REGARD TO VIKING PRODUCTS. ANY IMPLIED WARRANTIES INCLUDING THOSE OF MERCHANT ABILITY AND FITNESS FOR A PARTICULAR PURPOSE, ARE HEREBY LIMITED TO THE WARRANTY PERIOD SET FORTH ABOVE.

IN NO EVENT SHALL VIKING OR ITS AFFILIATES BE LIABLE FOR SPECIAL, INCIDENTAL OR CONSEQUENTIAL DAMAGES (INCLUDING LOSS OF USE) IN CONNECTION WITH THE PURCHASE, OPERATION OR USE OF VIKING SUITS WHETHER ARISING IN CONTRACT, TORT OR OTHERWISE, AND THE SOLE AND EXCLUSIVE LIABILITY OF VIKING AND ITS AFFILIATES UNDER THIS WARRANTY REGARDLESS OF THE FORM OF ACTION SHALL NOT EXCEED THE PURCHASE PRICE OF THE SUIT.

NEITHER DEALERS NOR ANY OTHER RETAIL OR OTHER SELLER OF THIS PRODUCT SHALL HAVE ANY AUTHORITY TO MAKE ANY WARRANTY OR TO PROMISE ANY REMEDIES IN ADDITION TO OR INCOSISTENT WITH THE TERMS STATED HEREIN.

Some states do not allow limitations on how long an implied warranty lasts, so the above information may not apply to you. Some do not allow exclusion of limitation of consequential damages, so the above limitation or exclusion may not apply to you.
